**更改車輛資料需知 Notice of Change of Vehicle Details**

- 登記車輛只限私家車。Nominated Vehicle(s) for Private Car only.
- 請附上所有登記車輛之車輛登記文件之副本以作記錄。請注意，本會有權拒絕向未有登記之車輛提供服務或即時收取港幣一千一百元(包括二百元行政費)之車輛資料不符費用。如日後閣下/貴公司有需要更改車輛資料，請盡快與本會聯絡。  
Please submit **photocopy of the Vehicle Registration Document(s)** of all nominated vehicles for our record. Members who need our emergency rescue service but have not submitted the said Vehicle Registration Document, there will be a charge for non-registered car at HK\$1,100(including \$200 administration fee) per service.
- 車輛文件之登記姓名必須與 申請人^相同；否則，本會將不接受該車輛之登記，亦不會提供任何服務 予該車輛。  
The name on the vehicle registration document must be the same as the applicant^; otherwise, the vehicle concerned will not be registered as a nominated car and the service rendered to the vehicle concerned will not be effective.  
^永久會員適用 Applicable for Life member only – 如申請人是一間公司的董事，以該公司名義註冊的車輛也可以成為登記車輛。申請人需附上車輛登記文件副本及公司的周年申報表，申請人必須是公司的董事。If the applicant is the Director of a company, the vehicle(s) registered under the company name can also be nominated car. The applicant should submit the copy of vehicle registration document together with The Company's Annual Return, and the applicant must be the Director of the Company.
- 每輛額外車輛年費為 HK\$900，詳情請聯絡會員部。  
Annual subscription for each additional car HK\$900 / year, please contact membership department for details.
- 如日後閣下/貴公司有需要更改個人及車輛資料，請盡快與本會聯絡。
